

Make Profits Easy Subscriber Agreement

This agreement (the "Agreement") is entered into as of today's date (the "Effective Date") by and between you (the "Subscriber") and Make Profits Easy, LLC. (DBA Realestatewebsitesotgo.com") with its principal place of business at 497 West Side Avenue Suite 134, Jersey City, New Jersey 07304 (collectively the "Parties").

WHEREAS, Make Profits Easy LLC provides, and Subscriber wishes to obtain, certain services to enable Subscriber to use an Make Profits Easy template site, host the Website ("Website") on Make Profits Easy LLC Server ("Make Profits Easy Web Site") such that third parties may access the Website via the World Wide Web.

Now, Therefore, in consideration of the covenants and conditions provided in this Agreement, and other good and valuable consideration, Make Profits Easy and Subscriber hereby agree as follows:

1.0 DEFINITIONS.

1.1 Website. "Website" means a facility for Subscriber to provide information to third parties via the World Wide Web via the MAKE PROFITS EASY Services (defined herein).

1.2 MAKE PROFITS EASY Servers. "MAKE PROFITS EASY Servers" are the servers on which the Website is hosted such that third parties may access the Website via the World Wide Web.

1.3 MAKE PROFITS EASY Web Site. "MAKE PROFITS EASY Web Site" shall mean that any site owned or operated by MAKE PROFITS EASY and/or any mirror sites or alternate domains pointing to MAKE PROFITS EASY Web Site or mirror sites.

1.4 Domains. MAKE PROFITS EASY has available a domain for Subscribers use. MAKE PROFITS EASY will determine on a case by case basis whether to allow Subscriber the use of the MAKE PROFITS EASY domain and whether to charge Subscriber for such use. In some cases MAKE PROFITS EASY may agree to purchase particular domains for Subscribers use at MAKE PROFITS EASY 's expense. In the event that MAKE PROFITS EASY purchases a domain specifically for a particular Subscriber to use, MAKE PROFITS EASY agrees to allow that Subscriber full use of the domain as long that Subscriber remains a Subscriber in good standing and does not default on payment or any other terms of this or other agreements with MAKE PROFITS EASY . In the event this agreement is terminated by MAKE PROFITS EASY or by Subscriber, MAKE PROFITS EASY will retain ownership and all rights to such domain unless Subscriber paid for domain registration when domain was originally registered or unless otherwise agreed to in writing.

1.5 Subscriber Owned Domain. "Subscriber Owned Domain" shall mean Subscriber's personally owned domain name, which redirects, points to or is hosted by MAKE PROFITS EASY . MAKE PROFITS EASY acquires no rights in Subscriber's personally owned domains.

1.6 MAKE PROFITS EASY Content. "MAKE PROFITS EASY Content" shall mean any and all proprietary images, artwork, copy, information, data, or knowledge licensed to Subscriber hereunder as part of the MAKE PROFITS EASY Services. The MAKE PROFITS EASY Content shall consist of Content located on and originating from the MAKE PROFITS EASY Web Site or otherwise provided to Subscriber by MAKE PROFITS EASY .

1.7 MAKE PROFITS EASY Proprietary Materials. "MAKE PROFITS EASY Proprietary Materials" shall mean collectively the images, artwork, copy, reports, information, data, knowledge, computer software, content and design of the MAKE PROFITS EASY Web Site, marketing materials and any other material provided by MAKE PROFITS EASY .

1.8 MAKE PROFITS EASY Services. "MAKE PROFITS EASY Services" shall mean the services defined in Article 2.0 of this Agreement which shall enable Subscriber to create, maintain, update and upgrade the Website and to host the Website on the MAKE PROFITS EASY Servers such that third parties may access the Website via the World Wide Web.

1.9 Subscriber Materials. "Subscriber Materials" shall mean any and all images, artwork, copy, information (including, without limitation, information in any file in any format), data, knowledge, computer software, and other materials of any kind provided by Subscriber for use with the Website.

2.0 MAKE PROFITS EASY SERVICES.

2.1 Hosting Services. For the term of this Agreement, MAKE PROFITS EASY shall host the Website on the MAKE PROFITS EASY Servers such that third parties may access the Website via the World Wide Web. There are currently no restrictions on the disk space used by Subscriber's Website, however MAKE PROFITS EASY retains the right to place restrictions if deemed necessary by MAKE PROFITS EASY .

2.3 MAKE PROFITS EASY Proprietary Materials. MAKE PROFITS EASY shall provide Subscriber use of the MAKE PROFITS EASY Proprietary Materials, strictly in accordance with the license granted herein, for the sole purpose of maintaining, updating and upgrading the Website. MAKE PROFITS EASY reserves the right to modify, remove, or add to the list of MAKE PROFITS EASY Content available to Subscriber at any time for any reason.

2.4 No Subscriber Internet Connection Equipment Provided. MAKE PROFITS EASY does not provide any modem, computer, or any other equipment or system for Subscriber to connect to the Internet. Subscriber is responsible for its modems, computers, operating systems and connection devices necessary for connecting to the Internet through which Subscriber can access the MAKE PROFITS EASY Services.

2.5 Revision of MAKE PROFITS EASY Services. MAKE PROFITS EASY may modify, suspend or discontinue any aspect of the MAKE PROFITS EASY Services at any time, including the availability of any MAKE PROFITS EASY Proprietary Materials. MAKE PROFITS EASY may also impose limits on certain features and services or restrict Subscriber's access to parts or all of the MAKE PROFITS EASY Services without notice or liability of any kind.

2.6 No Resale of MAKE PROFITS EASY Services. Subscriber agrees that this Agreement is personal to Subscriber and that Subscriber may not resell, lease, license, assign or redistribute any portion of the MAKE PROFITS EASY Services to any third party.

2.7 MAKE PROFITS EASY Leads. A subscriber may not resell, advertise or profit from a lead received buy MAKE PROFITS EASY . Any attempt to do so is therefore deemed "brokering" and is strictly forbidden by MAKE PROFITS EASY . If a subscriber is posting aproperty, they must have this property under contract.

3.0 LICENSE; PROPRIETARY RIGHTS.

3.1 MAKE PROFITS EASY Proprietary Materials License. MAKE PROFITS EASY hereby grants to Subscriber, and Subscriber hereby accepts, a personal, non-transferable, non-exclusive, limited license, for the term of this Agreement, to use one (1) copy of the MAKE PROFITS EASY Proprietary Materials (where applicable, in executable, object code form only) solely in connection with operating the Website (the "MAKE PROFITS EASY License"). Nothing herein shall be interpreted to mean, and MAKE PROFITS EASY does not grant, Subscriber any right or license in any MAKE PROFITS EASY proprietary images, artwork, copy, information, data, knowledge, computer software or any other material or information of any kind exclusive of the MAKE PROFITS EASY Proprietary Materials. Subscriber expressly understands that many of the images on the MAKE PROFITS EASY Web Site are only licensed for use within the MAKE PROFITS EASY Web Site and MAY NOT be used on other advertising without Subscriber first purchasing rights to use such images from the copyright holders.

3.2 No Sublicense. Nothing herein shall be interpreted to mean, and MAKE PROFITS EASY does not grant to Subscriber, any right or license to enter into sublicenses or redistribution agreements with respect to any portion of the MAKE PROFITS EASY Proprietary Materials.

3.3 Copyright Notices. The MAKE PROFITS EASY Proprietary Materials are protected by copyright pursuant to U.S. copyright laws, international conventions and other copyright laws, and are owned or controlled by MAKE PROFITS EASY . Subscriber will abide by any and all additional copyright notices, information, or restrictions contained in the MAKE PROFITS EASY Proprietary Materials.

3.4 MAKE PROFITS EASY License Restrictions. Except as provided for in this Agreement, Subscriber represents, warrants and covenants that Subscriber will not reproduce, modify, publish, transmit, participate in the transfer or sale of, distribute, publicly exhibit, display perform or digitally perform, or in any way exploit, any of the MAKE PROFITS EASY Proprietary Materials or the Website, in whole or in part.

3.5 No Derivative Works. Subscriber represents covenants and warrants that it shall not reverse engineer, decompile, translate, or develop derivative works based on, the MAKE PROFITS EASY Proprietary Materials, except that such restrictions shall not apply to the Subscriber Materials.

3.6 No Contesting of Rights. The Subscriber acknowledges and agrees that neither during the existence of this Agreement nor after the termination or expiration hereof, shall the Subscriber directly or indirectly contest or aid in contesting the validity or ownership of the MAKE PROFITS EASY Proprietary Materials or take any action whatsoever in derogation of MAKE PROFITS EASY 's rights therein or in breach of any terms and conditions contained in this entire Article 3.0.

3.7 Reservation of Rights. Any and all rights to use any MAKE PROFITS EASY Proprietary Materials not expressly granted to Subscriber under this Agreement are hereby reserved for MAKE PROFITS EASY (the "MAKE PROFITS EASY Reserved Rights"). Nothing contained in this Agreement shall affect, impair, or limit in any way MAKE PROFITS EASY 's rights to exploit fully any or all of the MAKE PROFITS EASY Reserved Rights.

3.8 MAKE PROFITS EASY Trademarks. Nothing herein shall be interpreted to mean, and MAKE PROFITS EASY does not grant Subscriber any right or license in any MAKE PROFITS EASY trademark, tradename, service mark, insignia, slogan, name, emblem, logo, symbol, design and/or other identifying characteristics owned by or associated with MAKE PROFITS EASY , its parent, its subsidiaries, its affiliates or Subscribers, in any manner whatsoever.

3.9 Subscriber Materials License. Subscriber hereby grants to MAKE PROFITS EASY a perpetual, non-exclusive license to reproduce, license, publish, distribute, transmit, broadcast, or publicly exhibit, display, perform or digitally perform and otherwise use the Subscriber Materials as necessary to provide the MAKE PROFITS EASY Services to Subscriber hereunder. Subscriber hereby agrees to now and forever release and hold MAKE PROFITS EASY, its Subscribers, subsidiaries, directors, officers, advertising agencies, suppliers, agents, affiliates and employees, harmless from any and all losses, damages, rights, claims and actions with respect to, or in any way arising from, MAKE PROFITS EASY's use of the Subscriber Materials (including, without limitation, any alleged or actual infringement of any proprietary rights, rights of privacy and publicity, moral rights, and rights of attribution in connection with the Subscriber Materials).

3.10 Proprietary Rights. Subscriber acknowledges and agrees that MAKE PROFITS EASY owns and shall retain all rights, title and interest in and to the MAKE PROFITS EASY Proprietary Materials, including, without limitation, all copies thereof and all rights to patents, copyrights, trademarks, service marks, trade secrets and other intellectual property rights inherent therein and appurtenant thereto, subject only to Subscriber's rights in and to the Subscriber Materials. Subscriber shall retain all rights, title and interest in and to the Subscriber Materials, including, without limitation, all copyrights, trademarks, patents, trade secrets, and any other proprietary rights inherent therein or appurtenant thereto.

4.0 SYSTEM RULES.

4.1 Subscriber agrees to be bound by rules that are important for the proper use of the Website and the MAKE PROFITS EASY Services. Subscriber's failure to follow these rules, whether set out in this Agreement, or in notices or bulletins posted or e-mailed by MAKE PROFITS EASY, may result in MAKE PROFITS EASY terminating this Agreement and Subscriber's MAKE PROFITS EASY Internet account. Subscriber hereby represents, warrants and covenants that Subscriber will abide by the following rules: (i) Subscriber will not use the Website or the MAKE PROFITS EASY Services to post, transmit, display, distribute or promote any unlawful, threatening, abusive, libelous, defamatory, obscene, vulgar, offensive, pornographic, profane, racist, sexually explicit or indecent material of any kind; (ii) Subscriber will not use the Website or the MAKE PROFITS EASY Services to encourage, promote, solicit or commit conduct that would constitute a criminal offense, give rise to civil liability or otherwise violate any local, state, national or international law; (iii) Subscriber will not use the Website or the MAKE PROFITS EASY Services to post, transmit, display, distribute or promote in any way, information, software, or other material that violates, plagiarizes or infringes the rights of third parties including, without limitation, copyright, trademark, patent, trade secret, rights of privacy or publicity or any other proprietary right; (iv) Subscriber will not use the Website or the MAKE PROFITS EASY Services to promote physical harm or injury against any group or individual; (v) (vi) Subscriber will not use the Website or the MAKE PROFITS EASY Services to post, transmit, display, distribute or promote material that exploits children under eighteen (18) years of age; (vii) (viii) Subscriber will not develop restricted or password-only access pages, or hidden pages or images (those

not linked to from another accessible page); (ix) Subscriber will not use the Website or the MAKE PROFITS EASY Services as storage for remote loading or as a door or signpost to another server; (x) Subscriber will not develop pages on the Website that consist of hyperlinks to content or materials of any kind in violation of the rules contained in this Article 4.0; (xi) Subscriber will not restrict or inhibit any other user from using and enjoying the user's Website or the MAKE PROFITS EASY Services; (xii) Subscriber will not use the Website or the MAKE PROFITS EASY Services to post, transmit, display, distribute or promote material of any kind that contains a virus or other harmful component; and (xiii) Subscriber will not use the Website or the MAKE PROFITS EASY Services to post, transmit, display, distribute or promote information or material of any kind that constitutes or contains false or misleading indications of origin or statements of fact.

4.2 Subscriber may advertise any Generic Domain or Subscriber Owned Domain at Subscribers discretion, with the following terms: Subscribers may not advertise in any media, or in any way that MAKE PROFITS EASY , at MAKE PROFITS EASY 's sole discretion, feels is not appropriate. Subscriber also agrees to hold MAKE PROFITS EASY harmless for any actions brought against MAKE PROFITS EASY as a result of Subscribers advertising. This hold harmless shall include, but not be limited to bandit signs. Subscribers should know the sign law in their respective area and abide by it accordingly.

4.3 SPAM - Any Subscriber using our servers to send unsolicited e-mail is subject to immediate termination. MAKE PROFITS EASY DOES NOT TOLERATE SPAM.

5.0 Subscriber Warranties. Subscriber represents and warrants that: (i) Subscriber owns, possesses or controls all right, title and interest to the Subscriber Materials; (ii) Subscriber has the full and unrestricted right to enter into this Agreement and Subscriber has and shall maintain all rights in and to the Subscriber Materials that are necessary to grant to MAKE PROFITS EASY the rights granted in this Agreement; (iii) the Subscriber Materials are true and accurate and do not and will not contain any misrepresentations of fact; (iv) the reproduction, licensing, use, publication, distribution, transmission, broadcast, or public exhibition, display, performance or digital performance of the Subscriber Materials as authorized herein, and all other use thereof in accordance with this Agreement, does not and will not, (a) violate or infringe the civil, contract or property rights, copyrights, trademark rights, rights of privacy or publicity, or other rights of any person or entity, (b) constitute false or misleading indications of origin; (c) slander, libel or defame any person or entity; (d) cause injury of any kind to any person or entity; or (e) violate any applicable laws, rules, regulations or other governmental regulations; (v) Subscriber is at least eighteen (18) years old; (v) Subscriber has, and shall maintain, from the Effective Date of this Agreement through the termination or expiration of this Agreement, a valid MAKE PROFITS EASY Internet account registered in Subscriber's name; and (vi) this Agreement has been duly and validly executed and delivered by Subscriber and constitutes the valid and binding agreement of Subscriber, enforceable against Subscriber in accordance with its terms.

6.0 Subscriber Indemnity. Subscriber hereby agrees to defend, indemnify and hold harmless MAKE PROFITS EASY , its subsidiaries and Subscribers, its directors, officers, employees, information providers, agents, licensors and licensees, and defend any action brought against same with respect to any and all costs, claims, demands, liabilities, losses, damages, judgments, settlements, costs and expenses (including attorneys' fees), asserted by a third party, arising out of or in connection with the Subscriber Materials, Subscriber's operation of the Website or any other acts by Subscriber in connection with Subscriber's use of the MAKE PROFITS EASY Services and the MAKE PROFITS EASY Proprietary Materials, including, without limitation: (i) any claim which if true, would constitute a breach of any of Subscriber's representations, warranties, covenants or agreements hereunder; (ii) claims arising from the negligence or willful misconduct of Subscriber; (iii) any actual or alleged infringement or violation of any patent, trademark, trade name, copyright, trade secret, license or any other third party contract or other right (including, but not limited to, misappropriation of trade secrets or violation of the right of publicity or privacy); (iv) claims for bodily injury (including death) and property damage; and (v) any claim for payment of compensation or salary asserted by an employee, subcontractor, agent or licensor of Subscriber. Notwithstanding MAKE PROFITS EASY 's foregoing rights in this Article 6.0, MAKE PROFITS EASY reserves for itself, at its own option, the exclusive right to settle, compromise and pay any and all claims, demands, proceedings, suits, actions or causes of actions which are brought against MAKE PROFITS EASY herein under the terms and provisions of this Article 6.0 and Subscriber shall in no event settle any such action without MAKE PROFITS EASY 's prior written consent. This entire Article 6.0 shall survive any expiration or termination of this Agreement.

7.0 SUBSCRIBER MATERIALS.

Subscriber acknowledges that Subscriber is solely responsible for the Subscriber Materials and that MAKE PROFITS EASY has no obligation under this Agreement for monitoring or verifying any information or materials included as part of the Subscriber Materials. Notwithstanding the preceding sentence, MAKE PROFITS EASY reserves the right at all times to disclose any Subscriber Materials, in whole or in part, as necessary to satisfy any law, regulation or government request, or to edit, or remove any Subscriber Materials, in whole or in part, that in the sole and exclusive discretion of MAKE PROFITS EASY , are objectionable or in violation of this Agreement. MAKE PROFITS EASY reserves the right to remove the Website from the MAKE PROFITS EASY Servers if the Website, in whole or in part, in the sole and exclusive discretion of MAKE PROFITS EASY , is objectionable or in violation of this Agreement.

8.0 ADVERTISING. MAKE PROFITS EASY may from time to time include small, non-intrusive advertisements within the MAKE PROFITS EASY Web Site.

9.0 TERM AND TERMINATION.

9.1 Term. The Agreement shall commence as of the Effective Date and shall be month to month, until terminated as provided herein.

9.2 Termination. MAKE PROFITS EASY may terminate the Agreement at any time and for any reason by notifying Subscriber of such termination. Such termination will take effect in thirty (30) days unless termination is a result of default by Subscriber. If termination is the result of a default by Subscriber, MAKE PROFITS EASY reserves the right to terminate Agreement immediately without notice. Subscriber may terminate this Agreement by providing MAKE PROFITS EASY thirty (30) days prior written notice of such termination; such termination shall be effective at the expiration of such thirty (30) day period. Subscriber shall remain liable for all charges for MAKE PROFITS EASY Services until such termination is effective. In the event MAKE PROFITS EASY terminates the Agreement before Subscribers paid time has expired, MAKE PROFITS EASY will reimburse the unused time to Subscriber. Set up fees will not be refundable. MAKE PROFITS EASY may retain all monies paid by Subscriber if the Agreement is cancelled because of Subscribers default under the terms of this Agreement, or if Subscriber terminates agreement prior to the end of the initial twelve-month term. If Agreement is terminated by either party, Subscriber must pay a new setup fee to reactivate. New setup fee will be determined by MAKE PROFITS EASY depending on the time and work involved in restoring files to server.

9.3 Reassignment of Subscriber's e-mail address. Upon termination of this Agreement, MAKE PROFITS EASY shall have the sole and exclusive right to reassign the Subscriber's e-mail address.

9.4 Termination of Agreement. Upon the termination of this Agreement, all rights of Subscriber under the MAKE PROFITS EASY License granted hereunder shall terminate and automatically revert to MAKE PROFITS EASY and Subscriber shall immediately discontinue the use of the MAKE PROFITS EASY Proprietary Materials and thereafter shall no longer use or have the right to use the MAKE PROFITS EASY Proprietary Materials or any variation or simulation thereof, or any word or trademark similar hereto, or to (directly or indirectly) develop, create, market, distribute, sell, license or sublicense, or advertise any products and/or services in connection with the MAKE PROFITS EASY Proprietary Materials. Upon the termination or expiration of this Agreement. Subscriber acknowledges that Subscriber's failure to cease the use of the MAKE PROFITS EASY Proprietary Materials upon termination or expiration of this Agreement shall result in immediate and irremediable damage to MAKE PROFITS EASY . Subscriber acknowledges and admits that there is no adequate remedy at law for such failure, and agrees that in the event of such failure, MAKE PROFITS EASY shall be entitled to equitable relief by way of temporary and permanent injunction and such other and further relief as any court with jurisdiction may deem just and proper.

10.0 DISCLAIMER OF WARRANTIES. THE MAKE PROFITS EASY PROPRIETARY MATERIALS AND THE MAKE PROFITS EASY SERVICES ARE PROVIDED "AS IS." TO THE FULLEST EXTENT PERMISSIBLE BY LAW, MAKE PROFITS EASY AND ITS SUBSIDIARIES AND SUBSCRIBERS MAKE NO REPRESENTATIONS OR WARRANTIES OF ANY KIND WHATSOEVER FOR THE MAKE PROFITS EASY PROPRIETARY MATERIALS OR THE MAKE PROFITS EASY SERVICES OR ANY BREACH OF SECURITY ASSOCIATED WITH THE TRANSMISSION OF SENSITIVE INFORMATION THROUGH THE USE OF THE MAKE PROFITS EASY PROPRIETARY MATERIALS OR THE MAKE PROFITS EASY SERVICES, FURTHER, MAKE PROFITS EASY AND ITS SUBSIDIARIES AND SUBSCRIBERS DISCLAIM ANY EXPRESS OR IMPLIED WARRANTIES, INCLUDING WITHOUT LIMITATION, NON-INFRINGEMENT, MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. MAKE PROFITS EASY DOES NOT WARRANT THAT THE FUNCTIONS CONTAINED IN THE MAKE PROFITS EASY PROPRIETARY MATERIALS OR THE MAKE PROFITS EASY SERVICES OR OTHER CONTENT OR MATERIALS CONTAINED THEREIN WILL BE UNINTERRUPTED OR ERROR FREE, THAT DEFECTS WILL BE CORRECTED, OR THAT THE MAKE PROFITS EASY PROPRIETARY MATERIALS OR THE MAKE PROFITS EASY SERVICES ARE FREE OF VIRUSES OR OTHER HARMFUL COMPONENTS. MAKE PROFITS EASY AND ITS SUBSIDIARIES AND SUBSCRIBERS MAKE NO WARRANTIES AND SHALL NOT BE LIABLE FOR THE USE OF THE MAKE PROFITS EASY PROPRIETARY MATERIALS OR THE MAKE PROFITS EASY SERVICES AND ANY ERRORS CONTAINED THEREIN UNDER ANY DIRECT OR INDIRECT CIRCUMSTANCES, INCLUDING BUT NOT LIMITED, TO MAKE PROFITS EASY 'S NEGLIGENCE.

11.0 LIMITATION OF LIABILITY. UNDER NO CIRCUMSTANCES SHALL MAKE PROFITS EASY OR ITS SUBSIDIARIES OR SUBSCRIBERS BE LIABLE FOR ANY SPECIAL OR CONSEQUENTIAL DAMAGES THAT ARE DIRECTLY OR INDIRECTLY RELATED TO THE USE OF, OR THE INABILITY TO USE, THE MAKE PROFITS EASY PROPRIETARY MATERIALS OR THE MAKE PROFITS EASY SERVICES, EVEN IF MAKE PROFITS EASY OR ITS SUBSIDIARIES OR SUBSCRIBERS OR AN AUTHORIZED REPRESENTATIVE THEREOF HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. SOME STATES DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU. 12.0 GOVERNING LAW. THIS AGREEMENT SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF COLORADO, WITHOUT REGARD TO CONFLICTS OF LAWS PROVISIONS.
